Read up to 70 pages of a TV pilot or episodic spec and provide:

- 90 minute meeting/discussion (via phone or Skype; no written notes given).....\$350
- or* 3-5 pages of overall notes and suggestions (no meeting/discussion).....\$400
- or* 3-5 pages of overall notes and suggestions *plus* line-by-line notes (script markup)....\$450
- or* The Works: Overall notes, line notes, *plus* 90 minute meeting/discussion.....\$500

Additional reading of same teleplay (revised drafts):

Story/outline services:

Read up to 15 pages of story/beat sheet/outline/treatment/notes/whatever and provide:

- 90 minute meeting/discussion (via phone or Skype; no written notes given).....\$250
- or* 3-5 pages of overall notes and suggestions (no meeting/discussion).....\$300
- or* The Works: Overall notes plus 90 minute meeting/discussion.....\$350
- Additional phone/Skype conversations per each 30 minutes.....\$75

Additional reading of same story/outline (revised drafts):

- 90 minute meeting/discussion (via phone or Skype; no written notes given).....\$125
- or* 3-5 pages of overall notes and suggestions (no meeting/discussion).....\$150
- or* The Works: Overall notes, line notes, plus 90 minute meeting/discussion.....\$175
- Additional phone/Skype conversations per each 30 minutes.....\$75

- Story breaking** (virtual whiteboard via Skype), first 2 hours.....\$350
- Each additional 30 minutes.....\$100

General consultation:
